AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A
MEMORANDUM OF UNDERSTANDING WITH CAVITE AGRIBUSINESS AND
TRAINING CENTER INCORPORATED FOR THE AGRIBUSINESS TRAINING
PROGRAM FOR OUR SEASONAL WORKERS DEPLOYING TO KOREA

REQUEST FOR A PASSAGE OF PROPOSED RESOLUTION
AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO
AGRICULTURAL SECTOR SEASONAL WORKERS EXCHANGE
AGREEMENT BETWEEN JEONGEUP-SI REPUBLIC OF KOREA AND THE
MUNICIPALITY OF NAIC, CAVITE

A council meeting was conducted and participated in by the OIC-PESO Manager, during which the Memorandum of Understanding (MOU) was read and reviewed. The MOU establishes a framework for collaboration between the Local Government Unit of Naic, Cavite and the Cavite Agribusiness and Training Center Incorporated for the recruitment, training, and potential employment of seasonal farm workers in Korea.

The committee found the MOU generally in order; however, several revisions were recommended to ensure clarity and effective implementation prior to approval. These include: (1) expressly stating in the MOU the name of Mayor Rommel Anthony V. Magbitang as the Local Chief Executive, as represented by the Local Government Unit of Naic, Cavite; (2) providing that all applicants must be residents of Naic for at least ten (10) years; (3) specifying that qualified applicants must be between thirty (30) to forty-five (45) years of age; and (4) clearly indicating the span or duration of the agribusiness training program.

At present, the Municipality of Naic has been allotted sixty-five (65) slots for deployment as seasonal farm workers to Jeongeup-si, Jeollabuk-do, Republic of Korea, seventeen (17) of which shall be filled by workers from the first batch who are eligible for re-contracting. With the incorporation of the recommended amendments, the committee respectfully recommends the passage of a resolution authorizing the Local Chief Executive to enter into Agricultural Sector Seasonal Workers Exchange Agreement between Jeongeup-si Republic of Korea and the Municipality of Naic, Cavite.
